1. The Government of the People's Republic of Bangladesh (GoB) has received a Loan (Loan Agreement No.BD-P107) from Japan International Cooperation Agency (JICA) toward the cost of Dhaka Mass Rapid Transit Development Project (Line-1) (hereinafter called "the Project").

- 2. The corridor of the Project: Kamlapur to Airport (Underground) and Notunbazar to Pitalganj Depot (Elevated)
- 3. Total length of the corridor: 31.241 kilometer (19.872 kilometer underground and 11.369 kilometer elevated).
- 4. The project comprises the following components:
 - i. Land Development of Depot;
 - ii. Civil Works of Depot;
 - iii. Construction of Main Line and Stations from Kamlapur to Airport (Underground 19.872 kilometer-) and Notunbazar to Pitalganj Depot (Elevated 11.369 kilometer). There are 12 Underground Stations in Kamlapur to Airport Route and there are 9 Stations (2 Underground and 7 Elevated) in Notunbazar to Pitalganj Depot;

- 5. A portion of the JICA fund will be utilized for the consultancy services for Construction Supervision of the Project.
- 6. All payments for the consultancy services will be made both in Local and Foreign Currency.
- 7. Dhaka Mass Transit Company Limited (hereinafter referred to as 'the Client') now invites Expression of Interest (EoI) in English from reputed International Consulting Firms, individual or in joint venture (hereinafter referred to as 'the interested Consultant') for short-listing for the consulting services for Construction Supervision, Institutional Development, Management and Operational Support under the project. The international Consulting Firm(s) may submit the EoI in association with National consulting firms.

- 8. The objective of the consulting services is to achieve the efficient and proper preparation and implementation of the Project through the following works:
 - i. Construction Supervision for Civil & Building Works, Electrical & Mechanical and Rolling Stock Packages;
 - ii. Interface management among Packages;
 - iii. Integration of system operation (system integration);
 - iv. Institutional Development Assistance;
 - v. Management and Operational Support;
 - vi. Facilitation of implementation of Environmental Management Plan (EMP), Environmental Monitoring Plan (EMOP) and Resettlement Action Plan (RAP);
 - vii. Technology Transfer including Training of DMTCL Staffs;
 - viii. Non-Rail Business Strategy Plan, Design and Development for Station Area;
 - ix. Security Assessment and Risk Mitigation;
 - x. Utility Relocation Assistance;

- 10. Dhaka Mass Transit Company Limited (DMTCL) will conduct the short-listing of interested consulting firms for the above-mentioned consulting services. The Lead firm must have following experiences (ongoing/completed projects) of rendering consulting services:
 - a) At least one experience of Construction Supervision for an underground urban railway project with the total project cost minimum 1 billion USD in South Asia or South East Asia for the past 10 years;
 - b) At least one experience of construction supervision for the JICA funded urban railway project with the total project cost minimum 1 billion USD with electrification design which is consistent with Dhaka MRT Line-6 during the past 10 years; and
 - c) At least one experience of construction supervision in any transportation projects in Bangladesh for the past 10 years.

- 13. According to JICA Procurement Guidelines, the Short-Listed consultants may undertake works in association with other consultants listed or not listed in the Short List as long as the Short-Listed consultants execute a major portion of the required services.

The Client will not be responsible for any costs or expenses incurred by the Firm(s) in connection with the preparation or submission of the EoI.
